Chairman Josh Feucht convened the adjourned session with Altena, Vanden Bosch, Birkey, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

Chairman Feucht added two liquor license applications to the Board agenda for today.

The Board minutes from April 27 and April 30, 2021 were reviewed. Motion by Birkey, second by Altena to approve and sign minutes. Motion carried.

Veteran Affairs Director Sharon Fuller was present to talk to the Board regarding moving Veteran Affairs into the old conservation office area this week. Conservation has moved out to the new nature center at Lake Pahoja. The Board agreed that it is okay to haul out the old office furniture and bring it to the city cleanup days this week.

Chairman Feucht introduced Resolution 2021-13 to make the second transfer to secondary roads from rural services. This transfer will be in the amount of \$1,137,320, making the total transfer \$2,274,641. Motion by Herman, second by Altena to approve and Chairman sign Resolution 2021-13. Motion carried. This is a summary of Resolution 2021-13. The complete text can be obtained at the Auditor Office or online at www.lyoncountyiowa.com under Supervisors then Resolutions.

Motion by Vanden Bosch, second by Herman to appoint Supervisor Jerry Birkey to the Northwest Iowa Regional Housing Authority. Motion carried.

Auditor Smit noted that the parcel designation in Ordinance 2020-04 should be Parcel D and not Parcel C. An error was noted when recording the Ordinance that two days after the ordinance was approved by the Board, the survey of the parcel was filed and the surveyor used Parcel D instead of the assigned Parcel C that was given and used throughout the process. Smit is looking into what the process is to get that changed/corrected.

The Board discussed appointees to the temporary redistricting commission. The Board is to appoint 3 members to the commission. Motion by Altena, second by Birkey to appoint Pam Moen, Angie Keizer, and Mark Behrens, with Ron Van Egdom as an alternate. Motion carried. Lyon County Democratic Co-Chairs appointed Larry Holland and Adam Kerkvliet as the other two members. The commission members will be certified to the Auditor.

Liquor license applications were received late Monday from Blind Butcher Brewing, LLC and Rock River Golf Club. Blind Butcher Brewing is a new facility in Lyon County located by Inwood. Motion by Herman, second by Birkey to approve applications. Motion carried.

Motion by Vanden Bosch, second by Altena to approve claims. Motion carried.

Economic Development Director Steve Simons updated the Board on the NW IA Tech Class Program with 8 school districts to talk about tech employment opportunities. An internship program for students aged 14-17 was introduced for this summer with LVO and Sudenga being two Lyon County businesses that will be participating. Students would be paid and receive some

certifications. Simons also talked about the American Rescue Plan and handed out a few fact sheets. Lyon County is estimated to receive \$2.2 million to be used for eligible items set forth by the United States Treasury.

Shane Walter gave a Sioux Rivers Mental Health update. Emmet County will be entering the region as of July 1, 2021. This will make 6 counties in the region. Walter discussed the challenge of covering and implementing the services required with limited dollars. Walter discussed the different legislation out there pertaining to mental health and the funding there of.

Engineer Daryl Albertson and Dave Jackson Road Superintendent joined the meeting. Jackson discussed where the crews are working in the county. The Lester Project settlement agenda item was tabled until the June 8th meeting.

Supervisor correspondence: Altena-Mental Health mtg; Feucht-attended Larchwood City Council with Engineer Daryl Albertson.

Employment changes: As 4-1-2021 Nayle Gill has been a certified jailer for 1 year. Sheriff Vander Stoep recommended Gill's wage be increased to \$19.83/hr.

Kyle Lems, deputy sheriff, has resigned with a last day of work as 4-30-2021.

Mitchell Van Beek has been hired as a sheriff deputy. Van Beek's first day will be May 10, 2021 at a salary of 70% (\$63,431) of the Sheriff. Upon certification, Van Beek's salary would increase to 73% of Sheriff's pay.

Jamie Kelly has been hired as a Motor Vehicle Clerk starting May 24, 2021 at a wage of \$16.50/hour. Kelly will have a 6-month performance and wage review. Other appointments requested by Treasurer Michele Stewart were: Hedy Kruger as Tax Deputy, Cheryl Bos as Motor Vehicle Deputy, Ashley Blauwet as Driver License Examiner/Motor Vehicle. Motion by Altena, second by Herman to approve these appointments. Motion carried.
