Chairman Josh Feucht convened the adjourned session with Altena, Vanden Bosch, Birkey, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

Maintenance Director Lance Iwen joined the meeting to discuss the part time cleaning position. Iwen states that even after advertising since early March, the position has had zero applicants. Iwen asked if the Board would consider making the position a fulltime position. There was discussion on the amount of hours currently allotted to the part time position (up to 25/week), how many hours are actually needed for the work to be done, rate of pay for part time position. The Board requested to readvertise the position with a starting wage at \$18/hour.

The minutes of the August 10, 2021 meeting were reviewed. Motion made by Altena to approve minutes, seconded by Herman. Motion carried.

The Board has received a road closure request for a portion of West Jefferson Avenue in Inwood. The request is to close from the intersection of Maple Street West to Garfield Street. The closure is for September 25th for a demolition derby. Motion by Birkey, second by Altena to approve the request. Motion carried.

Chairman Feucht held the second reading of Ordinance 2021-04 Flood Plain Management. The Board is scheduled to hold the 3rd reading and a public hearing on September 14th on the Ordinance.

The Board has received participation agreements back from Northwest Iowa Development, Western IA Tourism, and Northwest IA Regional Housing Trust Fund. Motion by Vanden Bosch, second by Altena to approve and sign the agreements. Motion carried. The agreements set out the services provided by the organizations.

Lyon County Economic Development Director Steve Simons joined the meeting to discuss the Northwest Iowa Regional Housing Trust Fund letter of support. Motion by Vanden Bosch, second by Birkey to sign letter. Motion carried.

Simons has also shared the census numbers that have been released. Lyon County has grown over the last 10 years.

Chairman Feucht introduced Resolution 2021-20 to authorize the creation of Fund 24000 American Rescue Plan. This fund will house the ARP funds from the US Treasury. Lyon County is set to receive \$2,283,271. Motion by Birkey, second by Altena to approve and Chairman sign Resolution 2021-20. Motion carried. This is a summary of the resolution. Motion by Herman, second by Vanden Bosch to approve claims. Motion carried.

Road Superintendent Dave Jackson and Engineer Tech Randy Hage joined the meeting. The Board reviewed the amendment to the 28E agreement between Lyon County and the City of Lester which outlines the changes to the payment schedule and lays out that \$14,250 of liquidated damages will be assigned to

the city and the \$500 for work done by the mayor. Motion by Herman, second by Vanden Bosch to approve amendment. Motion carried.

The Board received a petition to vacate a portion of secondary road right of way from the County Engineer. The petition requests a portion of Eagle Avenue from the South Row Line of 170th Street South to 100 feet North of the West 1/4 corner of Section 17, Township 99 North, Range 46 West. The Board will need to set a public hearing by resolution in order to take public comment on the vacation. There is land owned on the south side of the bridge that would lose access if the full road is vacated. Attorney Oetken stated that an easement would need to be given or Moglers would need to purchase the property before that part of the road can be vacated. It was decided to table the petition to vacate until clarification can be received on the actual description of the portion to be vacated.

Supervisor correspondence: Altena-Landfill, NW IA Workforce Development.

Employment changes: Jody Vande Weerd has been hired as a part-time clerk in the Recorder's office. Vande Weerd's first day will be 9-9-2021 at a wage of \$17.50/hour. Upon completion of probationary period, Vande Weerd's wage may go to \$18.00/hour as of 3-9-2022.

Carol Van Houten completed her probation period and will receive a 2.5% raise to \$21.68/hour as of 8-1-2021.
