Chairman Josh Feucht convened the adjourned session with Altena, Vanden Bosch, Birkey, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

ISAC years of service awards were presented to: Recorder Amie Griesse 11 years, Conservation Director Justin Smith 17 years, and Treasurer Michele Stewart 27 years. The Board thanked them for their service to Lyon County.

Minutes from the March 8, 2022 meeting were reviewed. Motion by Altena, second by Herman to approve and Chairman sign minutes. Motion carried.

Recorder Amie Griesse talked with the Board about the employee health fair that she has been planning with Sanford and IBC. They will be holding employee health screenings again and are looking to give an incentive to encourage participation. The tentative date is set for May 3 from 7 a.m. to 1:00 p.m. Public Health and Mental Health will have booths as well as other vendors will be at the fair. Motion by Herman, second by Birkey to approve a \$50 gift card incentive for employee participation in the health screenings. Motion carried. The cost for the gift cards will come from the health insurance fund.

Rebecca Bixler has requested a road closure request for a 5k run put on by Blind Butcher Brewery on June 11, 2022. The 5k will be a fundraiser for a cure for vision research. The request notes that EMS, Law Enforcement, Secondary Roads have all been notified of the date, time, and route. The race will be take place on gravel roads going around the section staring from from the brewery on Buchanan Avenue. Motion by Vanden Bosch, second by Altena to approve the request. Motion carried.

Chairman Feucht opened the public hearing for the 2023 fiscal year budget at 8:45 a.m. Present were: Elijah Helton NW IA Review, Mecenzie Setting New Century Press, Public Health Administrator Melissa Stillson, Sheriff Stewart Vander Stoep, Treasurer Michele Stewart. The public hearing was closed at 8:47 a.m. due to no public questions or comments.

Resolution 2022-15 setting elected official salaries for FY2023 was introduced. Salaries as of 7-1-2023 will be: Auditor \$69,203, Recorder and Treasurer \$68,219, Sheriff \$97,066, Attorney \$109,981, and Supervisors \$28,882 with an additional \$1,000 to chairman. Motion by, second by to approve and sign resolution 2022-15. Rollcall vote: District 2 Vanden Bosch Support, District 3 Altena Support, District 4 Birkey Support, District 5 Herman Support, District 1 Feucht Support. Motion carried. Resolution 2022-16 approving the FY2023 budget was introduced. Levies for FY2023 will be set at 3.5000 for General Basic, .64218 General Supplemental, 3.04543 Rural Services. This makes a total countywide levy of 7.18761, which is lower than FY2022. Tax dollars levied will be \$7,015979 which is also less tax asking than FY2022. Motion by Birkey, second by Vanden Bosch to approve and sign resolution. Motion carried. This is a summary of the

The Board discussed the appointment of a weed commissioner for the East side of the county. There were two applicants for the position. John Smidstra has held the position since 2001. Motion by Vanden Bosch, second by Altena to reappoint John Smidstra to the 2 year position. Motion carried.

The Board discussed the possibility of charging Sioux Rivers Mental Health Region for office space. As mental health employees are now regional employees in all other aspects(except benefits) it was noted that we charge \$300/month rent to all other non-county agencies that have office space within county buildings. Motion by Herman, second by Vanden Bosch to charge Sioux Rivers Mental Health Region \$300.00/month for office space. Motion carried.

Lyon County Riverboat Foundation is holding a spring mini grant again. Resolution 2022-19 states support of the applications being presented by departments in Lyon County. The ambulance is applying for jump bags for employee's vehicles, and conservation is applying for kayaks. Motion by Vanden Bosch, second by Altena to approve and sign the resolution. Motion carried.

Resolution 2022-18 approving the Ameritas plan amendments was introduced. Smit noted that this the deferred compensation plan that the county uses and now requires approval each year. Motion by Herman, second by Birkey to approve and sign resolution. Motion carried. This is a summary of the resolution. The Cost Allocation Plan has been returned to the Board for FY21 from CAS. The estimated amount that will be reimbursed is \$12,925.00. The invoice for the audit of the allocation plan is \$4,125. Motion by Birkey, second by Altena to approve the plan and invoice. Motion carried.

Chairman Feucht opened the public hearing to take comment on a budget amendment for FY 2022 at 9:15 a.m. Present were: Elijah Helton NW IA Review, Mecenzie Settig, Public Health Administrator Melissa Stillson. As there were no public comments or concern presented, the hearing was closed at 9:22 a.m. Motion by Birkey, second by Altena to approve and sign Resolution 2022-17 approving the budget amendment. Motion by Herman, second by Birkey to approve claims. Motion carried.

The Board discussed the issue of new hires receiving more vacation than what the handbook states is allowed. The new hire in conservation and secondary roads have been given more than what the handbook states. Board would like a memo sent to all department heads regarding the handbook vacation policy for new hires.

County Engineer Daryl Albertson joined the meeting. The final estimate approval for (116) and (117) paving projects is needed. These projects were finalized in 2018 and have now been cleared for closure and retainage can be released. Motion by Birkey, second by Vanden Bosch to approve final estimate. Motion carried.

The Board discussed the new hire of an assistant engineer. Herman brought up the vacation issue of giving 2 weeks and it should only be one. Albertson will talk with the new hire.

Supervisor correspondence: Herman-YES Center; Birkey-Farm Bureau; Altena-Farm Bureau, NW IA Workforce Development Board; Vanden Bosch-RIDES.

Employment changes: Conservation has hired Jen Schemmel as a full-time office manager. Schemmel starts March 21, 2022 at a salary of \$49,000.

Mark Hand has been hired as an EMT. Hand started March 3, 2022 at \$5.50/hour for on call time and \$10.50/hour for active time. Hand will be running nights and weekends.

Deputy Nathan Rozeboom has resigned as a deputy sheriff. Rozeboom's last day of work was March 15, 2022. Sheriff Vander Stoep has approve Rozeboom to work parttime when the department is short staffed due to illness and vacations.

Nick Brewer has accepted the Assistant Engineer position. Brewer will be starting on or before May 1, 2022. Brewer's salary will be set at \$115,000 with two week vacation, a \$5,000 increase in base salary upon successful licensure as a professional engineer in the State of Iowa, and the county will also provide a moving allowance of \$10,000 to be paid with Brewer's first paycheck.
