Chairman Josh Feucht convened the adjourned session with Altena, Vanden Bosch, Birkey, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

Lyon County Disability Services Coordinator Lisa Rockhill and Attorney Oetken joined the meeting to discuss with the Board the importance of setting a rate for court appointed attorneys. This was brought to light as Lyon County has received an invoice for \$250/hour. It was discussed that the Magistrate Judge appoints the attorney. Oetken noted that working as a court appointed attorney takes no less work or time and noted that the courts have stated that due to the rate set by the legislature in Code there may be issues in the future of filling appointed attorneys. Motion by Vanden Bosch, second by Altena to approve \$75.00/hour for court appointed attorneys. Motion carried. It was noted that with the setting of an approved rate, Ordinance 2020-02 will need to be amended to include said rate. Rockhill also noted that there may be a few other amendments of the ordinance in different sections. The first reading of the amendment will be August 23rd.

Minutes from the July 26, 2022 meeting were reviewed. Motion by Altena, second by Herman to approve and Chairman sign minutes. Motion carried.

Lyon County Ambulance is wishing to sell a Zoll Autopulse CPR machine. The Board will need to set a public hearing to take comment on the sale and also to receive and open bids. Motion by Herman, second by Birkey to set August 23, 2022 at 8:45 a.m as the public hearing date. Motion carried. It was also discussed that bid forms may be obtained from the Auditor's Office and should be submitted by Noon on August 22nd. Any questions regarding the machine should be directed to Ambulance Director Amy Borman. Bids will be presented and opened after the public hearing is held on August 23rd. The Board does have the right to decline any and all bids if they so choose.

Auditor Smit presented an updated elections security policy. The policy remained the same with the exception of the addition of the updated software version and the miniOVCS. Motion by Altena, second by Vanden Bosch to approve policy. Motion carried.

The annex building lighting was discussed. It seems that ballasts keep burning out at the annex. Maintenance Director Iwen has asked if the Board would just like to replace them as they burn out or look at upgrading a few at a time. The Board agreed to replace them as they go out.

Resolution 2022-35 declaring Lyon County a Sanctuary County regarding the 2nd Amendment was introduced. Motion by Herman, second by Birkey to approve and sign resolution. Motion carried. Resolution 2022-36 creating a new fund 35000 for opioid litigation funding was introduced.
