Chairman Josh Feucht convened the adjourned session with Altena, Vanden Bosch, Birkey, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

Lyon County Economic Development Director Steve Simons talked about the BIG Challenge award ceremony. Carroll Street Treat and S2B Fishing Supplies took 2nd and 3rd places respectively. Simons also noted that the Sudgenga project has received the IEDA agreement and the project is moving along. NCC will be commemorating a space in the atrium to former President Aletha Stubbe that Simons will be attending today.

Minutes from the November 8 and 15, 2022 meeting were reviewed. Motion by Altena, second by Birkey to approve and Chairman sign minutes. Motion carried.

Weed Commissioner Reports were reviewed by the Board. Motion by Vanden Bosch, second by Altena to approve and sign reports. Motion carried.

Chairman Feucht opened the public hearing at 8:45 to take comment on the proposal to incur noncurrent debt to fund the urban renewal projects. Present: Elijah Helton, NW IA Review via telephone. As there were no comments presented, the hearing was closed at 8:47 a.m. Resolution 2022-53 was introduced authorizing noncurrent debt. The Board would be approving up to \$511,000 to be used for TIF projects to be paid out of the secondary road fund and reimbursed with TIF dollars by June 30, 2024. Motion by Birkey, second by Herman to approve and sign resolution 2022-53. Motion carried. This is a summary of resolution 2022-53. The full text may be obtained at the Auditor's Office or online at www.lyoncounty.iowa.gov under Supervisors and Resolutions.

The Board reviewed an updated ACH agreement with Premier Bank. This is to allow an increased amount for payroll ACH's for the 15th of the month. Motion by Vanden Bosch, second by Altena to approve and sign agreement. Motion carried.

The Board reviewed the county TIF debt certifications due by December 1, 2022. The certifications will be used in the upcoming valuation work for FY2023/2024. The only urban renewal area adding new debt is the Lyon County Economic Development urban renewal area in the amount of 511,000. All other county TIFs (Dura-Lift and CFE Elevator) are in the process of paying off the associated development agreements previously certified. Motion by Birkey, second by Herman to approve and sign count TIF debt certifications. Motion carried.

The Board determined to table the TextMyGov decision until after the Supervisor District Meeting next week.

Laney Feight with Navigator Heartland Greenway pipeline stopped in to give an update and answer any questions the Board may have. Feight noted that the Right of Way team is the acquisition of easements in Lyon County. He also noted that the company has filed with the Iowa Utilities Board. It was asked if counties are asking for more control of pipeline depth. Feight noted that there are a few counties that are working with them to talk about using a

different depth than the standards. Feight was asked about damages/repair to pipeline and payments for such. Unintentional damage repairs can be paid to the landowner over time or in a lump payment. It was asked what the percentage of the project is needed to use eminent domain. Feight noted there is no precedent in IA Code to meet for seeking to use eminent domain, but noted that the company is not looking to use eminent domain.

County Engineer Daryl Albertson contacted Auditor Smit to let the Board know he will not be attending the meeting today. Albertson did want to tell the Board that the bridge approaches on K60 were being poured today.

Motion by Herman, second by Birkey to approve claims. Motion carried.
