Chairman Jerry Birkey convened the adjourned session with Vanden Bosch, Scholten, Altena, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

Minutes from the February 7th & 8th, 2023 meeting were reviewed. Motion by Altena, second by Scholten to approve and Chairman sign minutes. Motion carried.

Motion by Vanden Bosch, second by Altena to move forward with the ICIT Assessment for Lyon County. Motion carried.

EMA Director Ardyn Kopischke presented the EMA budget. Kopischke highlighted the increase in costs for Fuel, Utilities and other supplies. Discussion was had in regards to state grant requirements. The Board thanked Kopischke for his presentation.

Motion by Herman, second by Altena to table the Public Hearing for Max Proposed Levy for FY 24

Motion by Vanden Bosch, second by Altena to Rescind Permit Number 703. Effectively rescinding the Road Crossing permits for Summit Carbon Solutions.

Sioux Rivers Mental Health Director Breanna Koedam presented the increase Lisa Rockhill Salary for FY 23. Effective for the March 2023 pay period. Koedam stated 100% of Rockhill's salary is covered by the Sioux Rivers Region.

County Engineer Daryl Albertson joined the meeting. Albertson requested approval for two projects. STP-S-C060-(126)-5E-60 County road A18 from Big Sioux River East to IA 9 Intersection. Motion by Vanden Bosch, second by Scholten to approve, Motion carried. STP-S-C060-(127)-5R-60 County Road K16 from IA 9 North 3 miles to Minnesota State Line. Motion by Altena, second by Vanden Bosch to approve, Motion carried.

Albertson discussed the activities of the road crew. Removing snow from intersections as well as hauling gravel to cover the soft spots on the gravel roads.

Fair Board members Wes DeGroot and Jared Ageson joined the meeting to request funding for FY 24. Discussion about past Capital Improvements and future plans concerning the fair was discussed. The board thanked DeGroot and Ageson for presenting.
