Chairman Jerry Birkey convened the adjourned session with Vanden Bosch, Scholten, Altena, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

Jordan Metzger with Stone Group Architects was again present to discuss the proposal for the ARPA annex/sec road projects. County Engineer Albertson also joined the meeting to discuss a drawing made for his secondary road shop. The Board, Metzger, and Albertson discussed changes to the plan, materials to use, office space and other items. Metzger will use the plan to come back with a proposal. Metzger will confirm the fees for Stone Group and get a contract put together. Metzger would like to the project final review before Christmas and then after New Year to let project out for bids. This would allow the project to start as soon as possible in the spring.

Minutes from the September 12, 2023 meeting were reviewed. Motion by Vanden Bosch, second by Altena to approve and Chairman sign minutes. Motion carried.

The Board needs to set a public hearing date to take public comment on an amendment to the Lyon County Economic Development Urban Renewal Area. Motion by Altena, second by Vanden Bosch to approve Resolution 2023-33 setting the public hearing date as October 24, 2023 at 8:45 a.m. Motion carried. This is a summary of Resolution 2023-33. Albertson noted that the project has already hauled 22 Ton of gravel on the East side of the county.

Motion by Vanden Bosch, second by Herman to approve formal letter to DNR regarding the Rock Bottom Dairy expansion in Section 20 of Allison Township. Motion carried.

The Calico Skies Winery liquor license was tabled as no documents have been received yet.

It was noted that agenda items Resolution 2023-24 and 2023-25 should have been noticed as 2023-34 and 2023-35.

Lyon County Economic Development Director Steve Simons joined the meeting to inform the Board that the consultation meeting with West Lyon Community School for the plan amendment to the Urban Renewal Plan for the Lyon County Economic Development Urban Renewal Area will be Oct. 4 at 2:00 pm.

Maureen Hansen with the 3rd Judicial District and Glen Kruger, Probation Officer, joined the meeting to talk with the supervisors. Hansen wanted to give an overview of the department and give the Board a chance to ask questions or talk about concerns. Hansen noted that as of 7-1-2023 the department is now under the Department of Corrections. The Board thanked Hansen and Kruger for coming.

County Engineer Daryl Albertson joined the meeting. Albertson talked about the obstacles of finding new hires whom already have a CDL. It was noted that other counties are starting to pay for the CDL training when needed. The CDL program at NCC in Sheldon was discussed as an option. Albertson compared the training after hiring to sending new deputies to the academy or paying for EMT/paramedic schooling. The Board told Albertson to go ahead and move forward with it.

Albertson noted that the cold in place project on A18 is not finished. There will be an asphalt layer put over the top yet once this phase is cured.

New York Life representatives Deric Langenhorst and Adam Buss joined the meeting to present options on life insurance benefits for employees. The Board thanked Langenhorst and Buss for presenting.

Motion by Altena, second by Scholten to approve claims. Motion carried.
