LYON COUNTY AUDITORS OFFICE January 14, 2025

Chairman Jerry Birkey convened the adjourned session with Vanden Bosch, Altena, Scholten and Herman present. Motion carried assumes unanimous vote unless otherwise stated. Present were Melissa Stillson, Jen Smit, and Lyon County Reporter.

The Board started with the Pledge of Allegiance.

Minutes from the January 2, 2025 and January 3, 2025 meeting were reviewed. Motion by Herman, second by Scholten to approve and Chairman sign minutes. Motion carried.

Quarterly reports from the Recorder, Auditor, and Sheriff were reviewed. Recorder Amie Griesse was present for questions. Motion by Scholten, second by Vanden Bosch. Motion carried.

The FY2025/2026 Valuations were reviewed. Motion by Vanden Bosch, second by Altena to approve valuations. Motion carried.

Chairman Birkey opened the public hearing at 8:45 a.m. for public comment on authorization for Non-Current Debt transfer of \$5,000 from the health insurance fund to the Flex Account for 2024. Present for public hearing were Melissa Stillson, Jen Smit, and Isaac Yeager. No comments were made. Chairman Birkey closed the public hearing at 8:45 a.m.

Chairman Birkey introduced Resolution 2025-03 authorizing the prefunding of the County's medical flex spending fund (from 89000 Health Insurance Fund to 91000 Flex Spending Fund). Due to the first deposit into this account being 1-15-2025, but employees may claim funds as of 1-1-2025, the account needs to be funded by an internal loan. The amount is \$5,000 and will be repaid by 12-31-2025. Motion by Scholten seconded by Altena to approve and Chairman sign Resolution 2025-03. Motion carried. Laura Benson and Cindy Harpenau with MidSioux gave an annual report of last year and requested \$10,500 for FY2026. Harpenau reported MidSioux received a Riverboat Grant (funded over 3 years) and will make updates to the outreach center. The Board thanked Benson and Harpenau for coming and noted that budget funding would be considered during budget time.

Lyon County Economic Development director Jen Smit gave an update on surrounding communities. Discussed possible meetings with Skyler Wheeler and the Board.

The Board discussed the possible location for Public Health and Economic Development. A meeting with the building and grounds committee and Public Health Administrator and Economic Development Director will be scheduled in order to determine what is needed for a new location.

Treasurer Stacy Knobloch presented the Semi-Annual report for July 1, 2024 to December 31, 2024. Motion by Herman, second by Vanden Bosch to approve the Semi-Annual report. Motion carried.

The 28E Agreement with the Osceola County Attorney's office was discussed. Motion by Herman, second by Altena to sign the 28E Agreement. Motion carried.

Employee Changes- Alex Waagmeester a deputy in the Sheriff's office will be at 82% of the Sheriff's Salary as of 1-1-2025.

Mason Langenhorst a deputy in the Sheriff's office is at 73% of the Sheriff's Salary as of 12-13-2024 due to certification.

Devin Miller a deputy in the Sheriff's office is at 73% of the Sheriff's Salary as of 8-16-2024 due to certification.

Rob VerMeer is now a deputy in the Sheriff's office and is 83% of the Sheriff's salary as of 12-30-2024.

Steve Maurer a deputy in the Sheriff's office resigned as of 12-8-2024.

Motion by VandenBosch, second by Scholten to approve claims. Motion carried.
