Chairman Jerry Birkey convened the adjourned session with Vanden Bosch, Scholten, Altena, and Herman present. Motion carried assumes unanimous vote unless otherwise stated. Also present were Jen Smit and Tom Lawrence.

The Board started with the Pledge of Allegiance.

Minutes from the October 14^{th} meeting were reviewed. Motion by Altena, second by Scholten to approve and Chairman sign minutes. Motion carried.

Resolution 2025-25 was introduced to set a public hearing date to take comment on approving the urban renewal plan amendment. Motion by Herman, second by Altena to approve and sign resolution setting public hearing for November 18th at 8:45 a.m. Motion carried. This is a summary of the resolution. Resolution 2025-26 was introduced. The resolution would set a public hearing date to take comment on the proposal to incur noncurrent debt in connection with the plan amendment for the Lyon County Economic Development Urban Renewal Area. Motion by Altena, second by Vanden Bosch to approve and sign resolution setting public hearing for November 18th at 8:50 a.m.. Motion carried. This is a summary of the resolution. The Board reviewed the weed commissioner report from the East side. Motion by Vanden Bosch, second by Herman to approve and sign the reports. Motion carried.

The Board set a public hearing for rezone applications for November 12, 2025 at 8:40 a.m. Motion by Altena, second by Scholten to set public hearing. Motion carried.

The Board discussed shutting all the utilities off at the old Annex building at 315 First Avenue. All approved

The Board discussed the Municipal Solid Waste Sanitary Landfill Local Government Guarantee. Altena informed the Board that the Landfill was not asking for money at this time, but according to code needs the contracts on file. Altena motioned for the board to sign the contract, second by Vanden Bosch. Motion carried.

Motion by Vanden Bosch, second by Herman to approve claims with the exception of one US Bank claim for a training & education conference. Further discussion with Conference Board is needed. Motion was made by Altena, second by Scholten.

Employment changes: Riley Knobloch was hired on 10/21/2025 as a Part-Time Adm. Assistant-Collections in the Attorney's office with a starting wage of \$20/hour.

County Engineer Daryl Albertson presented that the bridge scheduled for work in 2026, that was to be rescheduled to 2030 is now going to be done next year. There was discussion about fixing the cement in Lester on the curve.

Albertson also commented that they have been busy painting the lines on the roads.

Albertson had the Board asked the Board to approve and sign the revised 5 year plan. Motion made by Scholten, second by Altena. Motion carried

Amy Jurich and Stewart Lee with IBC joined the meeting at 9:30 for follow up questions on the 1-1-2026 health insurance renewal. The Board decided to go with Sanford again next year as they are the only one that offered a cap for the next 2 years at 10.9% and 11.9%. The Board decided to go with the new HRA plan. IBC will manage payments after deductible is met. Open enrollment dates were set for November 17th, 18th, and 19^{th} . Motion by Herman, second by Altena to accept the Sanford Health Plan. Motion carried 5-0.

Jurich also noted that there will be 6% increase in the MetLife Dental plan and no increase in the Vision Plan.

Chairman Birkey noted that all 5 Supervisors will be attending the District Meeting on December $17^{\rm th}$.
