**RESOLUTION ADOPTING AND APPROVING THE FINAL PLAT OF
ZANGGER VINTAGE AIRPARK 2ND ADDITION
A SUBDIVISION OF PARCEL G IN THE SOUTHWEST QUARTER (SW ¼) OF
SECTION TWENTY-EIGHT (28), TOWNSHIP ONE HUNDRED (100) NORTH,
RANGE FORTY-SEVEN (47) WEST OF THE 5TH P.M., LYON COUNTY, IOWA**

WHEREAS, the proprietors and owners of the real property comprising Zangger Vintage Airpark 2nd Addition, Subdivision of Parcel G in the Southwest Quarter (SW ¼) of Section Twenty-Eight (28), Township One Hundred (100) North, of Range Forty-Seven (47), West of the 5th P.M., Lyon County, Iowa have presented to the Board of Supervisors of Lyon County, Iowa a Final Plat and Dedication of said Zangger Vintage Airpark 2nd Addition.

WHEREAS, the Preliminary Plat of Zangger Vintage Airpark a Subdivision of Parcel G in the Southwest Quarter (SW ¼) of Section Twenty-Eight (28), Township One Hundred (100) North, of Range Forty-Seven (47), West of the 5th P.M., Lyon County, Iowa. NOW, THEREFORE IT IS HEREBY RESOLVED that the Final Plat and Dedication of Zangger Vintage Airpark 2nd Addition a Subdivision of Parcel G in the Southwest Quarter (SW ¼) of Section Twenty-Eight (28), in Township One Hundred (100) North, of Range Forty-Seven (47), West of the 5th P.M., Lyon County, Iowa be and the same is hereby approved and adopted as presented. The Chairman of the Board of Supervisors and the Lyon County Auditor shall certify a copy of this Resolution which shall then be affixed to said Final Plat and Dedication.
