**CERTIFICATION (CANVASS) OF LYON COUNTY ELECTION RESULTS**  
**CITY-SCHOOL ELECTION**

WHEREAS, the CITY-SCHOOL ELECTION was held as prescribed by law on November 4, 2025, and

WHEREAS, the Board of Supervisors and *ex-officio* Board of Canvassers has canvassed the vote of said elections in accordance with §50.24 of the *Code of Iowa*, now therefore

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and *ex-officio* Board of Canvassers of Lyon County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the CITY-SCHOOL ELECTION, held November 4, 2025, and that no obvious clerical errors were identified during the canvass.

One thousand Six hundred Ninety (1,690) people voted at the polls on election day.

Seventy-Two (72) absentee ballots were accepted for counting.

Two (2) provisional ballots were accepted for counting (subset of absentee ballots).

A total of One thousand Seven hundred Sixty-Four (1,764) people voted.

All races are for a term of four (4) years unless otherwise noted.


