**Terms of Agreement:**

Lyon County will not reimburse for a tile crossing without being able to check all the following boxes:

- Notification of construction shall be submitted in writing to the Lyon County Engineers Office 48-hours before construction. Email: engineer@lyoncountyiowa.com
- Contractor shall submit a valid Certificate of Insurance for \$1,000,000 of coverage. The certificate must show Lyon County as an additional insured party.
- Tile crossings must be placed a minimum of 50-ft away from culverts and bridges.
- All traffic control signing and barricades must be in accordance with the 2009 MUTCD and shall be furnished by and maintained by the Applicant or Contractor.
- No payment shall be made for tile crossings that are connected to sanitary sewer lines.
- Only perpendicular tile pipe is permitted in the County ROW. No intakes, gate valves, etc in County ROW.
- Under no conditions will a trench for a tile crossing be left open overnight.
- No trenching/open cut shall occur before May 1 or after October 1.
- For open cut, tile shall be Schedule 40 and have a minimum diameter of 6 inches.
- Bored tile must be yellow mine pipe and a minimum diameter of 6 inches.
- All backfill material within the road must be a good, compactable material. Please send a copy of the backfill material ticket to the Lyon County Engineers Office. The road must be backfilled to its original condition.
- All additional material must be removed from the County ROW before reimbursement.
- Paved roads must be bored.
- The County will pay for one tile crossing per road per watershed.

**Lyon County maximum reimbursement for an open cut tile crossing:**

- 6" Tile Crossing \$1000
- 8" Tile Crossing \$1,050
- 10" Tile Crossing \$1,100
- 12" Tile Crossing \$1,150

**Lyon County maximum reimbursement rate breakdown for all bored tile crossings:**

- Mobilization \$300.00
- Utility Line Crossing \$150.00
- Tile/ROW Length \$31.00/ft

Applicant will be responsible for all construction cost and fees beyond what the County pays as listed above.
