Chairman Josh Feucht convened the adjourned session with Altena, Vanden Bosch, Birkey, and Herman present. Motion carried assumes unanimous vote unless otherwise stated.

The Board started with the Pledge of Allegiance.

The Board discussed entering a closed session under IA Code Section 21.5(1)(j) to discuss the purchase of particular real estate only where premature disclosure could be reasonably expected to increase the price the governmental body would have to pay for that property. Motion by Herman, second by Altena to move into closed session. Rollcall vote: District 1 Feucht Support, District 2 Vanden Bosch Support, District 3 Altena Support, District 4 Birkey Support, District 5 Herman Support. Motion carried. Board moved into closed session at 8:32 a.m.

Board moved out of closed session at 9:28 am with a motion by Birkey, second by Altena. Rollcall vote: District 1 Feucht Support, District 2 Vanden Bosch Support, District 3 Altena Support, District 4 Vanden Bosch Support and District 5 Herman Support. Motion carried.

In closed session the Board moved to go forward with negotiations on a piece of property by a motion by Vanden Bosch, and second by Herman. Rollcall vote was: District 1 Feucht Support, District 2 Vanden Bosch Support, District 3 Altena Support, District 4 Birkey Support, District 5 Herman Support. Motion carried.

The Board minutes from May 11, 2021 were reviewed. Motion by Altena, second by Herman to approve and sign minutes. Motion carried.

The Board received correspondence regarding the Rock Rapids Heritage Days road races. Motion by Birkey, second by Altena to approve request. Motion carried.

The Board reviewed a DNR construction permit application for Randy Van Veldhuizen for a dairy cattle head increase and the construction of a 8.4MG earthen manure storage basin at an existing lot in Section 27 of Allison Township. No correspondence has been received regarding the application from the public. Motion by Vanden Bosch, second by Herman to approve and Chairman sign DNR letter. Motion carried.

The Board reviewed a DNR construction permit application for Corwin Van Veldhuizen for a new 85 head mature dairy cattle free stall confinement building and construction of a 2.3MG earthen manure storage basin at an existing lot in Section 26 of Riverside Township. No correspondence has been received regarding the application from the public. Motion by Altena, second by Birkey to approve and Chairman sign DNR letter. Motion carried.

The Board received an updated liquor license application from Blind Butcher Brewing Company, LLC. The application that was approved on 5-11-2021 had an extra permission on it that is not needed. Today's application has that extra permission removed. Motion by Vanden Bosch, second by Altena to approve and Chairman sign application. Motion carried.

Auditor Smit noted that the Democratic Party changed their appointment to the Temporary Redistricting Commission on May 13th. This change was received

before the May 15 certification deadline. Randy Waagmeester will replace Larry Holland.

As the contract for the county audit will expire at the end of FY2021, an audit proposal ad will be put in the papers. Smit will reach out to the firms that bid last time as well as the State Auditor's Office.

Per the American Rescue Plan, Lyon County will be receiving \$2.28 million dollars. In preparation of receiving the funds and to determine the most beneficial projects to invest the funds (per the US Treasury guidelines) the Board discussed making a committee to work on putting ideas together. Supervisors Altena and Herman both volunteered to sit on the committee. The Board agreed that all department heads should be invited to be on the committee as well as a representative from DeNoble, Austin and Company, PC. Auditor Smit will send an email regarding the committee to department heads and DeNoble's.

Lyon County Economic Development Director Steve Simons gave the Board information about Alvord Days (June 4 & 5). T-Bone Trail blogger will be in Lyon County June 17-18 and will be staying and visiting places in Lyon County. People can find out more information about him on Facebook page "T Bone Trail Western Iowa". Simons will also be visiting at West Lyon tomorrow with the industrial tech instructor.

Engineer Daryl Albertson and Road Superintendent Dave Jackson joined the Board. Truck driver and part time office assistant positions closed yesterday and will start interview procedure next week. Nothing was received for the engineering tech position, so Albertson plans to readvertise. Albertson is moving the road crew to 4 10-hour days starting next week. There are 6 employees that wanted to stay on 8 hour days and Albertson agreed to let those stay on 8 hours as it is nice to have someone available on Fridays. The 4 10-hour days will run from Memorial Day to Labor Day. It is a trial run to see how it goes.

Chairman Feucht opened the public hearing at 10:12 a.m. to discuss the options of purchasing motor graders for secondary roads. Engineer Albertson talked about the three options available by law: GO Bonds, General Fund secured loan, and Road Use Tax Dollars secured loan. Chairman Feucht closed the public hearing at 10:35 a.m. The Board discussed the options and decided to go with the road use tax dollars secured loan option. Smit and Albertson will work with Dorsey & Whitney to move forward with the lender documents. The timeline will be to set a public hearing on June 8 with a public hearing held on June 22.

The Board received and reviewed the Waiver of Requirement of IA Code Section 368.7 for the City of Doon. The City of Doon is requesting to annex Parcel B in the East Half of Section 25-98-46. This property lies East of the city limits on the East side of Doon and contains 17.95 acres. Motion by Vanden Bosch, second by Birkey to approve and Chairman sign waiver. Motion carried.

The Board reviewed benefit payout to Michele Stewart as she moved to Treasurer as of May 1, 2021. Motion by Birkey, second by Altena to approve payout. Motion carried.

The Board received a resignation letter from Lyon County Recorder Eldon Kruse. Kruse will be retiring with July 5, 2021 being Kruse's last day. Kruse noted that he enjoyed serving Lyon County for the past 26 ½ years and strongly recommended the appointment of Deputy Recorder Amie Griesse. The

Board will begin the process to determine how the vacancy will be filled. The Board has 40 days from the date of the vacancy to fill the position.

Employment changes: Coreen Klarenbeek's hourly wage has been increased to \$14.75/hour effective May 19, 2021.

Nikki Baatz's hourly wage has been increased to \$14.82/hour effective May 19, 2021.

Supervisor correspondence: Altena - IA Workforce Development Board; Vanden Bosch - NW IA Planning and Development, RIDES; Feucht-Board of Health.

Motion by Birkey, second by Altena to approve claims. Motion carried.
